Whereas, The City asserts its rights under Wis. Stat. Sec. 66.1005(2) to continue to hold an easement and rights incidental in and to the easement areas within the vacated ROW, now, therefore, be it.

Resolved, by the Common Council of the City of Milwaukee, that the proper City officials, including the DPW Commissioner, are hereby authorized: (i) to sign Sewer and Water Easement in the form and substance submitted to this file (or in substantially the same form and substance as submitted,
