Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$1,415,878 for a total estimated cost of \$15,250,415.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$1,415,878. The total estimated cost of these projects is \$15,250,415.

N. 70th St. - W. Capitol Dr. to W. Fiebrantz Ave. (ST211160166): Install traffic calming speed hump (s). Further Resolved, That the City Engineer and the Commissioner of Public Works are hereby authorized to negotiate and enter into an agreement with the State of Wisconsin, Department of Transportation for the City to undertake construction management duties on the following projects: N. 76th St. (ST320081301) and W. Highland Ave. (ST320120301); and, be it

Further Resolved, That the City Engineer is authorized to approve and make periodic payments to the State of Wisconsin, Department of Transportation after receipt of invoices from said State for the city's share of the costs for said projects: N. 76th St. (ST320081301) and W. Highland Ave. (ST320120301); and, be it

Further Resolved, That upon the completion of projects N. 76th St. (ST320081301) and W. Highland Ave. (ST320120301) and a determination of the actual costs, it is understood that if the City of Milwaukee's share is less than the amount previously paid, the difference will be refunded to said City; and, be it
