## THE CHAIR

Resolution authorizing acceptance and funding of a Save Our Streets Task Force grant.

This resolution authorizes the Milwaukee Police Department to accept a Save Our Streets Task Force grant from the Federal Bureau of Investigation (FBI) in the amount of \$78,008. The purpose of this grant is to fund overtime expenses necessary for assistance to the FBI in detection, investigation, and prosecution of crimes against the United States.

Whereas, The City of Milwaukee appears to be eligible for a Save Our Streets Task Force grant from the Federal Bureau of Investigation (FBI); and

Whereas, The operation of this grant from 08/1/11 to 9/30/11 would cost \$78,008, of which 100% would be provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Police Department is authorized to accept this grant without further approval unless its terms change as indicated in Section 304-81, Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2011 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled: Save Our Streets Task Force:
