Whereas, The Historic Preservation Commission at its September 6, 2011, meeting voted unanimously to grant interim historic designation to the Lustron house located at 3645 S. 20th Place; and

Whereas, The Milwaukee Code of Ordinances requires hearing be held by the Historic Preservation Commission within 90 days of an interim designation to determine whether to make an interim designation permanent; and

Whereas, A hearing was held by the Commission at its November 7, 2011 meeting, meeting at which permanent designation of the Lustron home was considered; now, therefore, be it

Resolved, By the Historic Preservation Commission of the City of Milwaukee, that the house at 3645 S. 20th Pl. be denied permanent historic designation.
