# THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$192,000 for a total estimated cost of these projects being \$3,187,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$192,000 with the total cost estimated to be \$3,187,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

## 4th Aldermanic District

N. Cass St. - E. Michigan St. to E. Wisconsin Ave. (SM495150009): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$122,000. This project is anticipated to be completed during the 2015 construction season.

E. Clybourn St. - N. Van Buren St. to N. Harbor Dr. (WT410150703): Relaying water main and water main extension. (Nonassessable Water Fund Budget Line 5010 -- \$12,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost for this project including the requested

amount is \$300,000. This project is anticipated to be completed during the 2015 construction season.

5th and 9th Aldermanic Districts

N. 107th St. Bioswales - W. Good Hope Rd. to W. Brown Deer Rd. (SM499150101): Best Management Practices (BMP's) for the reduction of TSS in storm water. (Nonassessable Storm Water Quality Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$400,000. This project is anticipated to be completed during the 2015 construction season.

#### 10th Aldermanic District

W. Wells St. - N. 46th St. to N. 51st St. (SM495150010): Relaying sanitary and storm sewers. (Nonassessable Sewer Maintenance Relay Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$696,000. This project is anticipated to be completed during the 2015 construction season.

W. Wells St. - N. 51st St. to N. 55th St. (SM495150011): Sanitary Sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$144,000. This project is anticipated to be completed during the 2015 construction season.

#### 14th Aldermanic District

S. Clement Ave. at E. Wilbur Ave. (ST211150199): Intersection modifications. (Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$25,000. This project is anticipated to be completed during the 2015 construction season.

# City Wide

2015 Sewer work prior to paving (SM495150500): Sewer work prior to paving. (Nonassessable Sewer Maintenance Relay Fund -- \$100,000). The total estimated cost for this project including the requested amount is \$1,500,000. This project is anticipated to be completed during the 2015 construction season.

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
