A substitute ordinance relating to the change in zoning from Industrial-Heavy to Industrial-Mixed for redevelopment on land located at 3628 West Pierce Street, on the north side of West Pierce Street, west of South 36th Street, in the 8th Aldermanic District.

This zoning change was requested by TransCenter for Youth, which intends to use the site as a school.

Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-801.3.0026. The zoning map is amended to change the zoning for 3628 West Pierce Street, Tax Key No. 436-0004-110, from Industrial-Heavy (IH) to Industrial-Mixed (IM).
