The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-20.5-1-b-17 to 23 of the code is created to read:

## 101-20.5. Cruising Prohibited.

- 1. DEFINITIONS.
- b. "Designated area" means:
- b-17. All that portion of West National Avenue bounded by South 6<sup>th</sup> Street on the east and South Layton Boulevard on the west.
- b-18. All of South Cesar E. Chavez Drive.
- b-19. All that portion of South 16<sup>th</sup> Street bounded by West Mitchell Street on the north and West Forest Home Avenue on the south.
- b-20. All that portion of West Greenfield Avenue bounded by South 6<sup>th</sup> Street on the east and South Layton Boulevard on the west.
- b-21. All that portion of West Mitchell Street bounded by South 1<sup>st</sup> Street on the east and South 5<sup>th</sup> Street on the west.
- b-22. All that portion of West Historic Mitchell Street bounded by South 5<sup>th</sup> Street on the east and South 14<sup>th</sup> Street on the west.
- b-23. All that portion of West Mitchell Street bounded by South 14<sup>th</sup> Street on the east and South Layton Boulevard on the west.
