THE CHAIR

Resolution approving a final Certified Survey Map for land located on the north side of West Scott Street and west of South 6th Street to redivide three parcels for construction of a building and dedicate land for public street purposes, in the 12th Aldermanic District.

This resolution approves a final Certified Survey Map that redivides three parcels to accommodate the construction of a new building for the United Community Center, Inc. The map will dedicate a two-foot-wide section of land along South 6th Street for public street purposes to correct an encroachment of the City sidewalk on the property. Whereas, The Milwaukee Code of Ordinances, Chapter 119-5, Subdivision Regulations, requires City Plan Commission ("CPC") approval, conditional approval or disapproval of all Certified Survey Maps ("CSMs"), which provide dedication of land to the City of
