A substitute ordinance relating to shuttle vehicles providing service to General Mitchell International Airport.

100-50-1-b rc

- Analysis -

This ordinance exempts shuttle vehicles that are authorized by Milwaukee County to provide in-county airport shuttle service from the city licensing requirements for public passenger vehicles.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 100-50-1-b of the code is repealed and recreated to read:

100-50. Public Passenger Vehicle Permits.

- 1. REQUIRED BY VEHICLE OWNER.
- b. Exemptions. The following vehicles are exempt from the provisions of this subchapter:

b-1. Vehicles licensed by the Wisconsin department of transportation as human service vehicles as described in ch. Trans 301, Wis. Adm. Code.

b-2. Shuttle vehicles authorized by Milwaukee County to provide in-county shuttle service for General Mitchell International Airport under s. 4.05(4), Milw. County Code.
