This resolution directs the Commissioner of Public Works to execute State/Municipal Agreements with the Wisconsin Department of Transportation for the construction of West Center Street Intersection with Lisbon Ave/N 60th; North 27<sup>th</sup> Street Intersection with Locust, Center, & North; North 35<sup>th</sup> Street Intersection with Center Street; North 35<sup>th</sup> Street Intersections with North Ave and with Lisbon Ave.; and West Morgan Avenue Intersections with 20<sup>th</sup>, 16<sup>th</sup>, 13<sup>th</sup> and 6<sup>th</sup> Streets; and setting up design and real estate funding of \$887,500 of which \$650,250 is grantor funded and \$237,250 is City funded,

Whereas, Project agreements have been requested and received from the Wisconsin Department of Transportation (WisDOT) to be executed by the City of Milwaukee for the construction of West Center Street Intersection with Lisbon Ave/N 60th; North 27<sup>th</sup> Street Intersection with Locust, Center, & North; North 35<sup>th</sup>

Street Intersection with Center Street; North 35<sup>th</sup> Street Intersections with North Ave and with Lisbon Ave.; and West Morgan Avenue Intersections with 20<sup>th</sup>, 16<sup>th</sup>, 13<sup>th</sup> and 6<sup>th</sup> Streets with Federal and State aid under the Highway Safety Improvement Program:

State I.D. 2984-21-01, 71  
North 35<sup>th</sup> Street - Intersection with West Center Street

State I.D. 2984-21-02, 72  
North 35<sup>th</sup> Street - Intersections with North Avenue and with Lisbon Avenue

State I.D. 2984-21-03, 73  
West Morgan Avenue - Intersections with 20<sup>th</sup>, 16<sup>th</sup>, 13<sup>th</sup>, and 6<sup>th</sup> Streets

Whereas, The Department of Public Works shall notify the Common Council of the City of Milwaukee of project cost overruns and changes in scope approved by the Department of Public Works; and

Whereas, The Common Council of the City of Milwaukee recognizes that the City may be 100 percent liable for project cost overruns and changes in scope as approved by the Department of Public Works; and

Whereas, The Common Council of the City of Milwaukee recognizes that the City may be liable for any cost incurred by the State should the City decide to withdraw from the project; and

Whereas, Construction funds for the project will be included in a separate resolution; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the Commissioner of Public Works is hereby authorized to execute agreements for the programming, design, and construction of the aforementioned projects with Federal and State aid under the Surface Transportation Program, copies of which are attached and are incorporated into this resolution by reference as though set forth in full; and, be it

Further Resolved, That the Commissioner of Public Works is hereby authorized to undertake or engage a consultant to undertake preliminary engineering for the improvement of the aforementioned projects and to reimburse the WisDOT for design engineering costs they incur from the improvement; and, be it

Further Resolved, that the Commissioner of Public Works is hereby authorized and directed to sign documents that are required if right-of-way acquisition is necessary as part of the project work; and, be it

Further Resolved, That the City Comptroller is hereby authorized to create within the Capital Improvement Fund, Grant and Aid Projects, the necessary Project Grant Chartfield Values for design engineering for the projects (Expenditure) and transfer to any of these accounts the amount required under the grant agreement and City Accounting Policy but not to exceed a 10 percent increase of the total amounts reserved for the grantor's share and local share or \$5,000, whichever is greater, as follows:
