THE CHAIR

A substitute ordinance relating to parking controls in various Aldermanic Districts. This ordinance establishes the above-mentioned parking requirements in various parts Of the City. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-23-3 of the Code relating to No Parking is amended by striking the following:

“On the north side of West Warnimont Avenue from West Hamilton Court to South 63<sup>rd</sup> Street from 7:00 AM to 5:00 PM Except Saturday and Sunday. (11<sup>th</sup> Ward)”

Part 2. Section 101-23-3 of the Code relating to No Parking is amended by adding the following:

On the north side of West Kilbourn Avenue from North 23<sup>rd</sup> Street to a point 40 feet east

On the north side of West Warnimont Avenue from South Hamilton Court to South 63<sup>rd</sup> Street on school days from 7:00 AM to 4:30 PM

On the east side of North 12<sup>th</sup> Street from West Brown Street to a point 75 feet south

Part 3. Section 101-23-4-d of the Code relating to Two-Hour Parking is amended by striking the following:

“On the east side of North 27<sup>th</sup> Street from a point 550 feet south of West Silver Spring Drive to a point 300 feet further south thereof from 8:00 AM to 5:00 PM Except Saturday and Sunday”

“On the east side of North 27<sup>th</sup> Street from West Silver Spring Drive to a point 600 feet south from 8:00 AM to 5:00 PM Except Saturday and Sunday”

“On North Warren Avenue from East Albion Street north to East Brady Street”

“On East Lincoln Avenue from South Howell Avenue to South Robinson Avenue”

“On South 11<sup>th</sup> Street from West Lapham Street to West Madison Street”

Part 4. Section 101-23-4-d of the Code relating to Two-Hour Parking is amended by adding the following:

On the north side of West Euclid Avenue from South 16<sup>th</sup> Street to South 17<sup>th</sup> Street

On the south side of West Oklahoma Avenue from South 97<sup>th</sup> Street to South 98<sup>th</sup> Street

On North Warren Avenue from North Arlington Place to East Brady Street

On South 11<sup>th</sup> Street from West Madison Street to West Greenfield Avenue

On South 11<sup>th</sup> Street from West Orchard Street to West Lapham Boulevard

Part 5. Section 101-27-3-b-1 of the Code relating to Alternate Side Night Parking is amended by adding the following:

On South 36<sup>th</sup> Street from West Greenfield Avenue to West Orchard Street
