Whereas, Plaintiff David Fuerte incurred over \$24,000.00 in medical bills when he broke his ankle on January 23, 1998 at 2100 West Wells Street; and

Whereas, This property was owned by Campus Neighborhood Associates and leased by the City of Milwaukee, with the City being responsible for clearing ice and snow; and

Whereas; The claimed damages sustained by plaintiff exceed \$32,000.00; and

Whereas, The City Attorney recommends and the Common Council of the City of Milwaukee deems it expeditious and just to settle this lawsuit; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the proper City officers be and are hereby authorized and directed to issue a City check in the amount of \$15,000.00, payable to the
