 Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations.
 -Analysis-

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

2nd Aldermanic District

W. Melvina St. - N. 56th St. to N. 60th St. (Including part of abutting streets) (877-0805-6) File Number 951047: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, sodding, and grading. (Nonassessable Reconstruction Paving Fund 31-523---211-0001 -- \$99,740; Assessable Reconstruction Paving Fund 71-523---211-0001 -- \$21,260)

N. 71st St. - W. Hadley St. to W. Locust St. (878-0704-4) File Number 960854: Asphalt pavement resurfacing, replace all curb and gutter, replace sidewalk and driveway approaches where needed, sodding, and grading. (Nonassessable Reconstruction Paving Fund 31-523---211-0001 -- \$73,150; Assessable Reconstruction Paving Fund 71-523---211-0001 -- \$22,820)

Alley between W. Capitol Dr., W. Melvina St., N. 58th St. and N. 60th St. (E-W Leg and northerly 230 ft. m/l of the N-S Leg) (887-0869-1) File Number 960092: Concrete alley pavement reconstruction, replace some abutting sidewalk and driveway approaches, grading, and storm drainage facilities where needed. Alley between W. Lapham Blvd., W. Orchard St., S. 14th St. and S. 15th St. (885-0737-9) File Number 931154: Concrete alley pavement reconstruction, replace some abutting sidewalk and driveway approaches, grading, and storm drainage facilities where needed. (Nonassessable Alley Paving Fund 31-523---212-0001 -- \$49,790; Assessable Alley Paving Fund 71-523---212-0001 -- \$28,325)

Alley between N. Pinecrest St., N. Story Pkwy., W. Sunnyside Dr. and N. 50th St. (883-0514-1) File Number 961351: Concrete alley pavement reconstruction, replace some abutting sidewalk and driveway approaches, grading, and storm drainage facilities where needed. Whereas, The report of the Commissioner of Public Works has been filed with the City Clerk; and

Whereas, Notices have been sent to all interested persons and public hearings held; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works' Report, as amended at said Public Hearing, is approved and the properties therein identified are benefited; and, be it

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed with said work in accordance with said report pursuant to Section 66.60 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital purpose subaccounts; and, be it

Further Resolved, That the projects do not involve any parcels of land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That projects W. Melvina St. (877-0805-6), W. Wisconsin Ave. (876-0701-3), N. 71st St. (878-0704-4), Alley W. Auer Ave. (887-0847-1), Alley W. Capitol Dr. (887-0869-1), Alley W. Lapham Blvd. (885-0737-9), and Alley N. Pinecrest St. (883-0514-1) will be billed after January 1, 2000, but not before 12 months after the project contract has been completed.
