Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

8th Aldermanic District

S. 36th St. - W. Lapham St. to W. Greenfield Ave. (SM495010573): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$14,000)

W. Forest Home Ave. - W. Lincoln Ave. to S. 26th St. (SM495010572): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$7,000)

14th Aldermanic District

S. Alabama Ave. - E. Wilbur Ave. to E. Saveland Ave. (SM495010571): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$8,000)

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
