Whereas, The Milwaukee Historic Preservation Ordinance, s. 320-21 of the Code of Ordinances, provides that historic sites, structures and districts may be designated by the Common Council upon

Whereas, The Historic Preservation Commission, at its August 6, 2018 meeting, by a unanimous vote of four (4) ayes and two (2) excused, recommended historic designation of the property at 2635 West Greenfield Avenue (also addressed at 1406 South Layton Boulevard); and

Whereas, This building fulfills the following criterion set forth in s. 320-21-3:

the recommendation of the Historic Preservation Commission; and

- e-5. Its embodiment of distinguishing characteristics of an architectural type or specimen
- e-9. Its unique location as a singular physical characteristic which represents an established and familiar visual feature of a neighborhood, community or the city.
