Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$4,346,000 for a total estimated cost of these projects being \$5,084,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$4,346,000. The total estimated cost of these projects is \$5,084,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

#### 3rd Aldermanic District

N. Bremen St. - 300' north of E. Auer Ave. to E. Townsend St. (SM495170071) File Number 171215: Relaying combined sewer.(Nonassessable Sewer Maintenance Relay Fund -- \$219,000). The total estimated cost for this project including the requested amount is \$231,000. This project is anticipated to be completed during the 2018 construction season.

#### 4th Aldermanic District

W. Michigan St. - N. 28th St. to N. 29th St. (SM495170062) File Number 170857: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$36,000). The total estimated cost for this project including the requested amount is \$46,000. This project is anticipated to be completed during the 2018 construction season.

#### 6th Aldermanic District

- N. Dr. Martin Luther King Jr. Dr. N. 6th St. to W. Keefe Ave. (SM495180011) File Number 171479: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$62,000). The total estimated cost for this project including the requested amount is \$72,000. This project is anticipated to be completed during the 2018 construction season.
- N. 17th St. W. Nash St. to W. Vienna Ave. (SM495170066) File Number 171095: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$236,000). The total estimated cost for this project including the requested amount is \$248,000. This project is anticipated to be completed during the 2018 construction season.

The total estimated cost for this project including the requested amount is \$56,000. This project is anticipated to be completed during the 2018 construction season.
- W. Concordia Ave. N. 26th St. to N. 27th St. (SM495170069) File Number 171215: Relaying combined sewer.(Nonassessable Sewer Maintenance Relay Fund -- \$119,000). The total estimated cost for this project including the requested amount is \$131,000. This project is anticipated to be completed during the 2018 construction season.
- N. 25th St. W. Concordia Ave. to W. Hopkins St. (SM495170055) File Number 171095) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$352,000). The total estimated cost for this project including the requested amount is \$367,000. This project is anticipated to be completed during the 2018 construction season.
- N. 26th St. 390' south of W. Concordia Ave. to W. Concordia Ave. (SM495170070) File Number 171215: Relaying combined sewer.(Nonassessable Sewer Maintenance Relay Fund -- \$137,000). The total estimated cost for this project including the requested amount is \$149,000. This project is anticipated to be completed during the 2018 construction season.
- N. 34th St. W. Burleigh St. to W. Auer Ave. (SM495170013) File Number 161562: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$251,000). The total estimated cost for this project including the requested amount is \$263,000. This project is anticipated to be completed during the 2018 construction season.
- N. 50th St. W. Locust St. to W. Chambers St. (SM495180010) File Number 171479: Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$195,000). The total estimated cost

N. 52nd St. - W. Hope Ave. to W. Congress St. (WT410180637) File Number 161562: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$3,000 Nonassessable Water Fund Budget Line 6410 -- \$422,000.) The total estimated cost for this project including the requested amount is \$450,000. This project is anticipated to be completed during the 2018 construction season.

N. 56th St. - W. Leon Tr. To 400' north of W. Congress St. (WT410180636) File Number 161562: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$3,000 Nonassessable Water Fund Budget Line 6410 -- \$207,000.) The total estimated cost for this project including the requested amount is \$225,000. This project is anticipated to be completed during the 2018 construction season.

#### 10th Aldermanic District

Area bounded by N. Hawley Rd., W. Honey Creek Pkwy, W. Bluemound Rd. and W. Dickinson St. (SM494170015) File Number 171095: Sanitary Sewer lining. (Infiltration/Inflow Reduction Fund -- \$1,991,000). The total estimated cost for this project including the requested amount is \$2,011,000. This project is anticipated to be completed during the 2018 construction season.

#### 12th Aldermanic District

Alley west of S. 2nd St. - W. Oregon St. to 125' south of W. Oregon St. (SM492180010) File Number 171855: Combined sewer relay and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$17,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2018 construction season.

### City Wide

Crack filling of various streets by contract (ST211180169) File Number 171479: (Nonassessable Reconstruction Paving Fund -- \$50,000 additional funds). The total estimated cost for this project including the requested amount is \$550,000. This project is anticipated to be completed during the 2018 construction season.
