This resolution amends Common Council File #150991 relative to the acceptance and funding of the 2016 Sexually Transmitted Diseases Grant - HIV Prevention from the State of Wisconsin Department of Health Services for \$197,000. The purpose of the project is to reduce the incidence of AIDS/HIV in Milwaukee through preventive health education services, partner services and focused disease intervention activities.

Whereas, Common Council File #150991 authorized the Health Department to accept and fund the 2016 Sexually Transmitted Diseases Grant - HIV Prevention from the State of Wisconsin Department of Health Services for \$197,000; and

Whereas, the total expenditures of this program has been increased by \$24,500 to a total of \$221,500 of which all is provided by the grantor; and
