This resolution allows the City of Milwaukee to accept the amount of \$381,000 from the U. S. Department of Labor for the project entitled - Growing Milwaukee.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the U. S. Department of Labor for the project Growing Milwaukee in the amount of \$381,000; and

Whereas, The operation of this grant from 03/01/10 through 02/28/12 would cost \$381,000 which would be provided by the grantor; now therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Community Development Grants Administration shall accept this grant without further approval unless the terms of the grant change as indicated in Section 304-81, Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2010 Special Revenue - Grant and Aid

Projects, the following amounts for the project titled: Growing Milwaukee:
