Whereas, The agreement between the City Negotiating Team and Milwaukee District Council 48, AFSCME, AFL-CIO, has been reduced to writing; and

Whereas, Memorandum of Understanding embodying the agreement reached by the parties to such negotiations, copies of which are attached to Common Council File No. 981493 and incorporated herein as though fully set forth at length, subject to ratification by the Common Council; now, therefore, be it
