## THE CHAIR

Resolution relative to acceptance and funding of a Books2Go-Libros para Llevar Grant. (Library) This resolution authorizes the Milwaukee Public Library to accept and fund a Books2Go-Libros para Llevar Grant from the State of Wisconsin Department of Public Instruction in the amount of \$33,648 with a city share of \$4,028 and a grantor share of \$29,620. The purpose of the project is to expand library services to Latino families with young children who currently do not use the library. Whereas, The City of Milwaukee appears to be eligible for grant funds from the State of Wisconsin for the purpose of expanding library services to Latino families with young children who currently do not use the library; and

Whereas, The operation of this grant from 01/22/03 to 12/31/03 would cost \$33,648 of which \$4,028 (12%) would be provided by the city and \$29,620 (88%) would be provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Milwaukee Public Library shall accept this grant without further approval unless the terms of the grant change as indicated in Common Council File 940843 (Grant Ordinance); and, be it

- 1. Expend from the amount budgeted for specified purposes as indicated in the grant budget and incur costs consistent with the award date;
- 2. Expend from the 2003 grant budget funds for specific items of equipment;
