Substitute resolution determining it necessary to make various nonassessable public improvements at various locations.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

1st Aldermanic District

N. 21st St. - W. Olive St. to W. Congress St. (SM495030222): Relaying sanitary sewer.

N. 27th St. - A point 170 feet m/l south of W. Roosevelt Dr. to a point 370 feet m/l north of W. Roosevelt Dr. (SM495030223): Relaying sanitary sewer.

3rd Aldermanic District

E. Auer Ave. - N. Humboldt Bd. to 370 feet m/l east of N. Dousman St. (SM495030226): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$25,000)

3rd and 6th Aldermanic Districts

E. Locust St. - The Milwaukee River to N. Humboldt Bd. (SM495030230): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$25,000)

4th Aldermanic District

W. Juneau Ave. - N. 8th St. to N. 11th St. (WT410041080): Relaying water main. (Nonassessable Water Fund -- \$10,000)

N. 10th St. - W. Highland Ave. to W. Winnebago St. (WT410041081): Relaying water main. (Nonassessable Water Fund -- \$10,000)

5th Aldermanic District

W. Center St. - N. 76th St. to N. 92nd St. (WT410041082): Hydrant alteration. (Nonassessable Water Fund -- \$10,000)

12th Aldermanic District

W. Greenfield Ave. - S. 10th St. to S. 17th St. (SM495030232): Combined sewer relay. (Nonassessable Sewer Maintenance Relay Fund -- \$75,000)

14th Aldermanic District

S. Superior St. - E. Conway St. to a point 110 feet m/l southeast of E. Texas Ave. (SM495030225): Combined sewer relay. (Nonassessable Sewer Maintenance Relay Fund -- \$50,000)

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
