THE CHAIR

Substitute ordinance to further amend the 2004 rates of pay of offices and positions in the City Service under control of the Common Council (District Council #48, Association of Scientific Personnel & TEAM).
The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 3 of ordinance File Number 030414 relative to rates of pay of offices and positions in the City Service is hereby amended as follows (Effective Pay Period 1, 2003 - December 22, 2002):

Under Pay Range 205, add the following paragraph: "Employees not represented by a certified collective bargaining unit shall be paid the following biweekly rates effective Pay Period 1, 2002: \$986.40, 1,054.11, 1,097.60, 1,120.48, 1,143.35, 1,166.16 and 1,204.02.

In addition, above employees eligible for the Clerical Merit Increment shall be paid \$1,199.94 biweekly.

Under Pay Range 425, add the following paragraph: "Employees not represented by a certified collective bargaining unit shall be paid the following biweekly rates effective Pay Period 1, 2002: \$1,090.29, 1,116.31, 1,139.83, 1,166.33 and 1,206.15.
