THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

1st Aldermanic District

Area bounded by W. Villard Ave., N. 19th St., N. 22nd St., and the alley south of W. Villard Ave. (SW170050114): Relocate sanitary sewers.

3rd Aldermanic District

E. Brady St. at N. Astor St. (ST211060177): Remove and replace concrete curb and gutter. (Nonassessable Reconstruction Paving Fund -- \$3,000)

4th Aldermanic District

N. Market St. (West Side) - E. State St. to E. Highland Ave. (ST211060171): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$3,000)

9th Aldermanic District

N. 76th St. - W. Florist Ave. to W. Clinton Ave. (WT410061130): Hydrant and blowoff alterations. (Nonassessable Water Fund -- \$15,000)

10th Aldermanic District

N. 66th St. - W. Stevenson St. to W. Mt. Vernon Ave. (SM495050092): Cleaning, sealing and repairing sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$13,000)

12th Aldermanic District

W. Lincoln Ave. at S. 8th St. (ST211060176): Constructing concrete traffic island. (Nonassessable Reconstruction Paving Fund -- \$2,000)

S. 14th St. - W. Lincoln Ave. to W. Windlake Ave. (ST211060172): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$3,000)

Various Aldermanic Districts

Various locations. (BR100060001): Bridge administration/indirect costs. (Bridge Construction Project Account -- \$40,000)

Various locations. (BR100060101): 2006 bridge inspection. (Bridge Construction Project Account -- \$150,000)

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
