ALD. HENNINGSEN

A substitute ordinance relating to a disadvantaged business enterprise certification or recertification fee.

81-41.5 rc

Currently, the fee for certification or recertification of a city disadvantaged business enterprise is 0.2% of the gross sales, with the fee not to exceed \$2,400. Under this ordinance, a flat fee of \$50 shall be paid by an entity seeking certification or recertification as a disadvantaged business enterprise.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 81-41.5 of the code is repealed and recreated to read:

**81-41.5. Disadvantaged Business Enterprise Certification and Recertification.**

The fee for certification or recertification of a city disadvantaged business enterprise shall be \$50.
