Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

6th Aldermanic District

N. 7th St. - 290 feet m/l south of W. Chambers St. to W. Chambers St. (SM495020102) File Number 010040: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$148,000)

7th Aldermanic District

N. 24th Pl. - W. Lloyd St. to W. Medford Ave. (SM495020124) File Number 010600: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$252,000)

W. Lloyd St. - N. 24th Pl. to N. 27th St. (SM495020128) File Number 010600: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$73,000)

; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the Commissioner of Public Works is authorized and directed to proceed with said work; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
