THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$6,000 for a total estimated cost of these projects being \$106,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$6,000 with the total cost estimated to be \$106,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

2nd Aldermanic District

W. Custer Ave. - N. 60th St. to N. 64th St. (ST211150212): Install traffic calming devices. (Nonassessable Reconstruction Paving Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$16,000. This project is anticipated to be completed during the 2015 construction season.

14th Aldermanic District

E. Rusk Ave. - S. Kinnickinnic Ave. Ave. to a point west (ST214150104): Concrete alley replacement;

replace curb and gutter, walk, and driveway as necessary. (Developer Paving Fund -- \$4,000). The total estimated cost for this project including the requested amount is \$35,000. This project is anticipated to be completed during the 2015 construction season.

15th Aldermanic District

N. 17th St. - W. North Ave. to W. Lloyd St. (SM499150109): Stormwater improvements. (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$1,000). The total estimated cost for this project including the requested amount is \$55,000. This project is anticipated to be completed during the 2015 construction season.

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it
