Resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$8,017,000 for a total estimated cost of these projects being \$8,869,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$8,017,000. The total estimated cost of these projects is \$8,869,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

W. Reichert Pl. - N. 27th St. to 240 feet west of N. 27th St. (WT410160716) File Number 150322: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$75,000). The total estimated cost for this project including the requested amount is \$90,000. This project is anticipated

to be completed during the 2016 construction season.

#### 2nd Aldermanic District

W. Fairmount Ave. - N. 62nd St. to N. 63rd St. (WT410160675) File Number 150118: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$85,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2016 construction season.

#### 4th Aldermanic District

E. Chicago St. - N. Water St. to N. Jackson St. (SM495150093) File Number 151137: Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$1,992,000). The total estimated cost for this project including the requested amount is \$2,017,000. This project is anticipated to be completed during the 2016 construction season.

N. Jefferson St. - E. Menomonee St. to E. Chicago St. (WT410140619) File Number 140280: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$175,000). The total estimated cost for this project including the requested amount is \$190,000. This project is anticipated to be completed during the 2016 construction season.

N. Jefferson St. - E. Buffalo St. to E. St. Paul Ave. (SM495100122) File Number 070081: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$179,000). The total estimated cost for this project including the requested amount is \$190,000. This project is anticipated to be completed during the 2016 construction season.

E./W. St. Paul Ave. - N. 4th St. to N. Broadway (SM495110305) File Number 111578: Combined sewer relay and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$1,230,000, Additional Funds). The total estimated cost for this project including the requested amount is \$1,750,000. This project is anticipated to be completed during the 2016 construction season.

Alley between N. Broadway, E. Buffalo St., E. Chicago St., and N. Water St. (south 202 feet of the easterly north-south leg) (SM495150094) File Number 151137: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$96,000). The total estimated cost for this project including the requested amount is \$106,000. This project is anticipated to be completed during the 2016 construction season.

#### 5th Aldermanic District

W. Hadley St. - N. 88th St. to N. 89th St. (WT410160610) File Number 141514: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$90,000). The total estimated cost for this project including the requested amount is \$105,000. This project is anticipated to be completed during the 2016 construction season.

W. Vera Ave. - N. Park Manor Dr. to N. 97th St. (WT410160654) File Number 150118: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$190,000). The total estimated cost for this project including the requested amount is \$205,000. This project is anticipated to be completed during the 2016 construction season.

N. 88th St. - W. Center St. to W. Hadley St. (WT410160612) File Number 141514: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$175,000). The total estimated cost for this project including the requested amount is \$190,000. This project is anticipated to be completed during the 2016 construction season.

#### 7th Aldermanic District

W. Maxwell Pl. - N. 52nd St. to W. Fond du Lac Ave. (WT410160605) File Number 141514: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$160,000). The total estimated cost for this project including the requested amount is \$175,000. This project is anticipated to be completed during the 2016 construction season.

#### 7th, 10th, and 15th Aldermanic Districts

W. Center St. - N. Sherman Blvd. to N. 52nd St. (SM495160022) File Number 151521: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$1,147,000). The total estimated cost for this project including the requested amount is \$1,172,000. This project is anticipated to be completed during the 2016 construction season.

#### 11th Aldermanic District

W. Ohio Ave. - S. 76th St. to S. 80th St. (WT410160627) File Number 141514: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$535,000). The total estimated cost for this project including the requested amount is \$560,000. This project is anticipated to be completed during the 2016 construction season.

W. Tripoli Ave. - S. 67th St. To S. 68th St. (WT410160668) File Number 150118: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$170,000). The total estimated cost for this project including the requested amount is \$185,000. This project is anticipated to be completed during the 2016 construction season.

W. Warnimont Ct. - S. 68th St. to 160 feet west of S. 68th St. (WT410160622) File Number 141514: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$70,000). The total estimated cost for this project including the requested amount is \$85,000. This project is anticipated to be completed during the 2016 construction season.

S. 77th St. - 570 feet north of W. Burdick Ave. to W. Morgan Ave. (WT410160625) File Number 141514: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$645,000). The total estimated cost for this project including the requested amount is \$680,000. This project is anticipated to be completed during the 2016 construction season.

#### 13th Aldermanic District

W. Whitaker Ave. - S. 20th St. to S. Louisiana Ave. (WT410160604) File Number 141514: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$220,000). The total estimated cost for this project including the requested amount is \$235,000. This project is anticipated to be completed during the 2016 construction season.

S. 25th St. - W. Holt Ave. to W. Warnimont Ave. (WT410160614) File Number 141514: Relaying

water main. (Nonassessable Water Fund Budget Line 6410 -- \$340,000). The total estimated cost for this project including the requested amount is \$355,000. This project is anticipated to be completed during the 2016 construction season.

#### 15th Aldermanic District

W. Center St. - N. 25th St. to N. 26th St. (SM495150088) File Number 150997: Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$108,000). The total estimated cost for this project including the requested amount is \$120,000. This project is anticipated to be completed during the 2016 construction season.

W. Lloyd St. (Extended) - South of W. Fond du Lac Ave. to N. 20th St. (SM495150051) File Number 150997: Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$273,000). The total estimated cost for this project including the requested amount is \$285,000. This project is anticipated to be completed during the 2016 construction season.

N. 26th St. - W. Center St. to 300 feet north of W. Center St. (SM495150089) File Number 150997: Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$62,000). The total estimated cost for this project including the requested amount is \$74,000. This project is anticipated to be completed during the 2016 construction season.
