The City cost of the projects approved by this resolution is estimated to be \$2,450,000. The total estimated cost of these projects is \$2,761,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

W. Lawn Ave. - 500 feet west of N. 13th St. to 800 feet west of N. 13th St. (WT410100024) File Number 091432: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$75,000). The total estimated cost for this project including the requested amount is \$90,000. This project is
