Substitute motion amending the Common Council Procedure and Rules relating to files authorizing grant and aid funded capital projects submitted by "The Chair".

Under this motion, files authorizing grant and aid funded capital projects may not be accepted for introduction by "The Chair" unless the file is completely drafted and accompanied by a completed fiscal note, a completed grant analysis form, and a certification from the Comptroller that the file has been reviewed and approved for sufficiency of funds, proper identification of funding sources, and sufficiency of reporting for purposes of internal auditing.

It is moved, by the Common Council of the City of Milwaukee, that Article IV, Section 1, Subsection 3, Paragraph a of the Common Council *Procedure and Rules* is amended to read:

### ARTICLE IV: COUNCIL FILES

### Section 1. Introduction of Files.

3. Files Introduced By "The Chair". a. Only matters sponsored by a common council member and identified as to sponsorship may be introduced to the common council, except those files submitted by "The Chair". Except as provided in par. [[b]] >><u>c</u><<, files submitted by "The Chair" shall be submitted to the city clerk no later than the close of business on the fourth business day before the common council meeting on which they are to be introduced. Files submitted by "The Chair" shall be referred to the president and to the chairs of the committees to which they would be assigned. If both the president and the appropriate chair consent to the introduction of a file, it shall be deemed introduced and referred to committee. If either the president or the appropriate chair does not consent to the introduction of a file, it shall not be introduced.

It is further moved, that Article IV, Section 1, Subsection 3, Paragraph b of the Common Council *Procedure and Rules* is renumbered Paragraph c.

It is further moved, that Article IV, Section 1, Subsection 3, Paragraph b of the Common Council *Procedure and Rules* is created to read:

b. Files authorizing grant and aid funded capital projects shall not be accepted for introduction by "The Chair" unless the file is completely drafted and accompanied by a completed fiscal note, a completed grant analysis form, and certification from the Comptroller that the file has been reviewed and approved for sufficiency of funds, proper identification of funding sources, and sufficiency of reporting for purposes of internal auditing.
