Resolution relative to acceptance and funding of an Expanding Public Access to Technology Grant. (Library)

This resolution authorizes the Milwaukee Public Library to accept and fund a Grant from the Bill and Melinda Gates Foundation in the amount of \$87,701 with a city share of \$1,401 and a grantor share of \$86,300. The purpose of the project is to expand public access to computers and the Internet.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Bill and Melinda Gates Foundation for the purpose of expanding public access to computers and the Internet; and

Whereas, The operation of this grant from 02/01/00 to 06/30/00 would cost \$87,701 of which \$1,401(2%) would be provided by the city and \$86,300(98%) would be provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Milwaukee Public Library shall accept this grant without further approval unless the terms of the grant change as indicated in Common Council File 940843 (Grant Ordinance); and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2000 Special Revenue--Grant and Aid Projects, the following amounts for the project titled "Expanding Public Access to Technology Grant:"

- 2. Create the necessary Special Revenue Fund Grant and Aid Project/Grant and Project Level values; budget to these Project/Grant values the amount required under the grant agreement;
- 3. Establish the necessary City Share Project values; and, be it

Further Resolved, That these funds are budgeted for Milwaukee Public Library which is authorized to:

- 1. Expend from the amount budgeted for specified purposes as indicated in the grant budget and incur costs consistent with the award date;
