Resolution authorizing the transfer and expenditure of \$175,000 from the Development Fund for the Vliet Street Initiative Commercial District Project. (DCD) This resolution approves the expenditure of \$175,000 for the Vliet Street Initiative Commercial District Project. The commercial district improvements include storefront improvements, acquisition and redevelopment of commercial properties, and other commercial district identification enhancements. Whereas, The 2004 Capital Budget for the City of Milwaukee ("City") contains \$175,000 in the Development Fund; and

Whereas, The City has an ongoing commitment to the revitalization of neighborhood commercial districts; and

Whereas, The Vliet Street Initiative Commercial District Project will further sustain and enhance the revitalization of the commercial district; and

Whereas, The City was awarded a \$175,000 federal appropriation for the Vliet Street Initiative, which will match the amount of City funds for this project; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the proper City officials are authorized and directed to transfer \$175,000 from the Development Fund Account to the
