This ordinance amends s. 101-27-3-b-1 relating to alternate side night parking exceptions by adding S. 7th Street from W. Greenfield Avenue to W. Mitchell Street, S. 17th Street from W. Mitchell Street to W. Burnham Street and S. 15th Place from W. Washington Street to W. Scott Street.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-27-3-b-1 of the code relating to Alternate Side Night Parking Exceptions is amended by adding the following:

On S. 7th Street from W. Greenfield Avenue to W. Mitchell Street.

On S. 15th Place from W. Washington Street to W. Scott Street.

On S. 17th Street from W. Mitchell Street to W. Burnham Street.
