Resolution relating to expenditure of funds to be reimbursed by greater than anticipated revenue. (Election Commission)

This resolution authorizes the Election Commission to expend additional funds for various expenses associated with unscheduled elections in 2003. The Election Commission would be authorized to expend an additional \$310,973 for remaining elections and election services in 2003.

Whereas, Common Council File 980965 established procedural guidelines related to the expenditure of funds to be reimbursed by greater than anticipated revenues; and

Whereas, The Election Commission has administered and funded unanticipated recall elections for Milwaukee County and the State of Wisconsin; and

Whereas, Milwaukee County has reimbursed the City \$108,148.09 for this service; and

Whereas, The Election Commission deposited a check of \$7,722.61 from Boise Office Solutions into the general fund for merchandise originally purchased by the Election Commission and returned by the Election Commission; and

Whereas, Milwaukee County will reimburse the City an additional \$195,103; and

Further Resolved, That the City Comptroller be, and hereby is, authorized and directed to establish the necessary accounts and accounting procedures to carry out the intent of this resolution.
