Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

N. 65th St. - W. Clarke St. to W. Center St. (Sponsored by the City of Wauwatosa) (ST211010163)
File Number 001024: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$30,200; Nonassessable Reconstruction Paving Fund -- \$2,100)

W. Congress St. - W. Fond du Lac Ave. to N. 60th St. (ST211020129) File Number 000838: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$10,300; Nonassessable Reconstruction Paving Fund -- \$47,300)

W. Marion St. - N. 60th St. to N. 61st St. (ST21110109) File Number 990845: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$2,000; Nonassessable Reconstruction Paving Fund -- \$36,000)

Alley between W. Fiebrantz Ave., W. Grantosa Dr., W. Palmetto Ave., N. 98th St., N. 99th St., N. 100th St., and the City Limits (Sponsored by the City of Wauwatosa) (ST212020133) File Number 011242: Asphalt alley pavement resurfacing. (Assessable Alley Paving Fund -- \$10,300; Nonassessable Alley Paving Fund -- \$1,000)

Whereas, Notices have been sent to all interested persons and public hearings held; now, therefore,

be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works' Report, as amended at said Public Hearing, is approved and the properties therein identified are benefited; and, be it

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed with said work in accordance with said report pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances, and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That projects N. 65th St. (ST211010163), W. Congress St. (ST211020129), W. Marion St. (ST21110109), N. Murray Ave. (ST211020133), N. Shepard Ave. (ST211020153), Alley W. Congress St. (ST212020134), and Alley W. Fiebrantz Ave. (ST212020133), will be billed after January 1, 2004; and project N. 74th St. (ST211010141) will be billed after January 1, 2005, but not before 12 months after the project contract has been completed; and, be it

Futher Resolved, That the following projects be deleted from the 2002 Paving Program.
