THE CHAIR

Resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$8,930,000 for a total estimated cost of these projects being \$9,907,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$8,930,000. The total estimated cost of these projects is \$9,907,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

W. Roosevelt Dr. (south side) - N. Teutonia Ave. to N. 22nd St. (SM495100244) File Number 101095: Relay sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$156,000). The total estimated cost for this project including the requested amount is \$171,000. This project is anticipated to be completed during the 2012 construction season.

W. Roosevelt Dr. - N. 27th St. to N. 30th St. (SM495100247) File Number 101095: Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$490,000). The total estimated cost for this project including the requested amount is \$505,000. This project is anticipated to be completed during the 2012 construction season.

### 3rd and 6th Aldermanic Districts

E. Chambers St. - N. Richards St. to N. Humboldt Blvd. (SM495110016) File Number 101439: Combined large diameter sewer lining and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$715,000). The total estimated cost for this project including the requested amount is \$745,000. This project is anticipated to be completed during the 2012 construction season.

### 4th Aldermanic District

N. 15th St. - W. Wisconsin Ave. to W. State St. (SM495100066) File Number 100013: Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$407,000). The total estimated cost for this project including the requested amount is \$419,000. This project is anticipated to be completed during the 2012 construction season.

N. 17th St. - W. Vliet St. to 430 feet m/l north of W. Vliet St. (SM495100167) File Number 100723: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$104,000). The total estimated cost for this project including the requested amount is \$119,000. This project is anticipated to be completed during the 2012 construction season.

### 5th Aldermanic District

W. Capitol Dr. - W. Grantosa Dr. to Grantosa Creek (SM495110010) File Number 101172: Storm sewer relocation. (Nonassessable Sewer Maintenance Relay Fund -- \$21,000). The total estimated cost for this project including the requested amount is \$31,000. This project is anticipated to be completed during the 2012 construction season.

### 6th Aldermanic District

N. Booth St. - E. Chambers St. to E. Burleigh St. (SM495100232) File Number 101095: Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$734,000). The total estimated cost for this project including the requested amount is \$749,000. This project is anticipated to be completed during the 2012 construction season.

E. Burleigh St. - N. Richards St. to N. Booth St. (SM495100234) File Number 101095: Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$216,000). The total estimated cost for this project including the requested amount is \$231,000. This project is anticipated to be completed during the 2012 construction season.

W. Chambers St. - N. 8th St. to N. 14th St. (SM495110042) File Number 101543: Relay combined sewer and combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund - \$425,000). The total estimated cost for this project including the requested amount is \$440,000. This project is anticipated to be completed during the 2012 construction season.

N. Dr. Martin Luther King Jr. Dr. - W. Keefe Ave. to N. Port Washington Ave. (SM495110026) File Number 101439: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$92,000). The total estimated cost for this project including the requested amount is \$104,000. This project is anticipated to be completed during the 2012 construction season.

N. Port Washington Ave. - N. Dr. Martin Luther King Jr. Dr. to W. Olive St. (SM495100237) File Number 101095: Relay sanitary sewer and combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$1,204,000). The total estimated cost for this project including the requested amount is \$1,219,000. This project is anticipated to be completed during the 2012 construction season.

W. Ring St. - N. 9th St. to N. 12th St. (SM495110041) File Number 101543: Relay combined sewer and combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$378,000). The total estimated cost for this project including the requested amount is \$393,000. This project is anticipated to be completed during the 2012 construction season.

N. 14th St. - W. Chambers St. to W. Burleigh St. (SM495110039) File Number 101543: Combined large diameter sewer lining and relay. (Nonassessable Sewer Maintenance Relay Fund -- \$170,000). The total estimated cost for this project including the requested amount is \$185,000. This project is anticipated to be completed during the 2012 construction season.

#### 6th and 7th Aldermanic District

W. Chambers St. - N. 18th St. to N. 24th St. (SM495110060) File Number 111024: Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$695,000). The total estimated cost for this project including the requested amount is \$720,000. This project is anticipated to be completed during the 2012 construction season.

#### 8th Aldermanic District

W. Burnham St. - S. 33rd St. to S. 35th St. (SM495110023) File Number 101439: Relay sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$172,000). The total estimated cost for this project including the requested amount is \$196,000. This project is anticipated to be completed during the 2012 construction season.

S. 35th St. - 300 feet m/l north of W. Burnham St. to W. Burnham St. (SM495110024) File Number 101439: Relay sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$99,000). The total estimated cost for this project including the requested amount is \$123,000. This project is anticipated to be completed during the 2012 construction season.

S. 36th St. - W. Burnham St. to W. Maple St. (SM495120018) File Number 111024: Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$14,000). The total estimated cost for this project including the requested amount is \$24,000. This project is anticipated to be completed during

the 2012 construction season.

#### 12th Aldermanic District

W. Grant St. - S. 10th Pl. to S. 15th St. (SM495110091) File Number 111024: Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$279,000). The total estimated cost for this project including the requested amount is \$294,000. This project is anticipated to be completed during the 2012 construction season.

#### 14th Aldermanic District

E. Lincoln Ave. - S. Kinnickinnic Ave. to S. 1st St. (ST211110101) File Number 111168: Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$80,000, Additional Funds). The total estimated cost for this project including the requested amount is \$659,000. This project is anticipated to be completed during the 2011 construction season.

#### City Wide

2012 Manhole Inspection (SM495120501) File Number 111168: (Nonassessable Sewer Maintenance Relay Fund -- \$79,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2012 construction season.

2012 Sewer work prior to paving (SM495120500) File Number 111168: (Nonassessable Sewer Maintenance Relay Fund -- \$2,400,000). The total estimated cost for this project including the requested amount is \$2,500,000. This project is anticipated to be completed during the 2012 construction season; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the Commissioner of Public Works is authorized and directed to proceed with said work; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
