footnote "(JJ) as follows: "To expire 09/30/03 unless the Breast and Cervial Cancer Screening Grant, available form the State of Wisconsin Division of Health and Family Services, is extended"; under "Disease Control and Prevention Division" add the title "West Nile Virus Surveillance Grant (VV)" and add one position of "Nuisance Control Officer .5 FTE (X)(VV)" and one position of "Nuisance Control Officer .2 FTE (X) (VV)" and amend footnote "(VV)" as follows: "To expire 06/30/03 unless the West Nile Virus Surveillance Grant is extended. .5 FTE of the Environmental Hygenist position funded by the Urban Air Toxics Grant."

Part 3. Section 1 of ordinance File Number 010468 relative to offices and positions in the City Service is hereby amended as follows:

Under "Milwaukee Public Library, Technical Services Bureau" add footnote "(Y)" designation to one position of "Management Librarian"; under "Automation Section" add footnote "(Y)" designation to one position of "Network Manager."

Part 4. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

Part 5. The provisions of this ordinance are deemed to be in force and effect from and after the first day of the first pay period following passage and publication.

Part 6. This ordinance will take effect and be in force from and after its passage and publication.
