Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$16,997,754 for a total estimated cost of these projects being \$21,205,754.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$16,997,754. The total estimated cost of these projects is \$21,205,754.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

W. Silver Spring Dr. at N. Teutonia Ave. (Intersection Modifications) (ST320050601) (2080-08-00) File Number 040866: Intersection modifications. City Share Non-Assessable Paving Fund -- \$500,000).

These funds are to be transferred to the construction account (ST320050610) (2080-08-70).

Previously authorized for road construction: \$750,000.00
