Whereas, The Capital Budget for the City of Milwaukee ("City") contains \$175,000 in the Neighborhood Commercial District Street Improvement Fund; and

Whereas, The City has an ongoing commitment to the revitalization of neighborhood commercial districts; and

Whereas, The Bronzeville Commercial District Enhancement Project will further sustain the revitalization of the commercial district; and

Whereas, These public way improvements will greatly enhance the Bronzeville Cultural and Entertainment District; now, therefore, be it
