# The Chair

Substitute resolution relative to the acceptance and funding of the 2014-15 Family Foundations Comprehensive Home Visiting Grant from the State of Wisconsin Department of Children and Families.

This resolution authorizes the Health Department to accept and fund the Family Foundations Comprehensive Home Visiting Grant from the State of Wisconsin Department of Children and Families in the amount of \$2,547,555 with a grantor share of \$1,566,763 (62%) and a city share of \$980,793 (38%). The purpose of the grant is to serve families in need of services related to improving pregnancy outcomes, enhancing family functions, preventing child abuse and neglect and assuring child readiness for school.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the State of Wisconsin Department

of Children and Families to improve pregnancy outcomes, enhance family functions, prevent child abuse and neglect and assure child readiness for school; and

Whereas, The continued operation of this grant program from 10/01/14 to 09/30/2015 would cost \$2,547,555 comprised of \$1,566,763 (62%) grantor share and \$980,793 (38%) City Share; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that acceptance of this grant from the State of Wisconsin Department of Children and Families is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant parent of the 2014 Special Revenue Grant and Aid Projects Fund, the following amounts for the program titled Comprehensive Home Visiting Grant:

- 2. Create the necessary Special Revenue Fund Grant and Aid Project/Grant and Project Levels; budget against these Project/Grant values the amount required under the grant agreement; and, be it
- 3. Establish the necessary City Share Project Values; and, be it

Further Resolved, That these funds are budgeted to the Health Department which is authorized to:

- 1. Expend from the amount budgeted sums for specified purposes as indicated in the grant budget and incur costs consistent with the award date; and
- 2. Expend from the 2014 grant budget for training and out-of-town travel by departmental staff;
- 3. Expend from the 2014 grant budget funds for specific items of equipment; and
- 4. Enter into subcontracts and leases as detailed in the grant budget; and, be it
