Whereas, The City is relaying their existing combined sewers in W. National Avenue and S. 39th Street ahead of the National Avenue resurfacing project; and

Whereas, The City has requested permission from the Village to relocate a combined sewer manhole in the intersection of W. National Avenue and S. 39th Street into the Village to avoid utility conflicts during construction; and

Whereas, The City has requested permission from the Village to relocate a combined sewer in S. 39th Street into the Village to avoid utility conflicts during construction; and

Whereas, The City has requested permission from the Village to relocate the point where the Village's sanitary sewer connects to the City's combined sewer to a manhole in the intersection of W. National Avenue and S. 39th Street; and
