Resolved, By the Common Council of the City of Milwaukee that the proper City officers be and hereby are authorized and directed to issue a City check in the amount of \$440,430.03 plus simple interest at 0.8% from January 1-31, 2008, and simple interest at 1.0% thereafter until date of payment, payable to the order of U.S. Bank and the law firm of Michael, Best & Friedrich in final settlement of this lawsuit, said amount up to \$450,000 to be charged to the Contingent Fund, Account No. 0001-9990-C001-006300; and be it

Further Resolved, That for and in consideration of the above-referenced payment, plaintiff and its attorney will provide to the City a satisfaction of judgment of the court action.
