THE CHAIR

A substitute ordinance relating to temporary variance permits to exceed noise and vibration standards.

80-66-1-b am

80-73-3-a-2 am

With respect to the procedure for issuance of temporary variance permits to exceed noise and vibration standards, this ordinance removes the code language stating that the special community events for which these permits may be issued must be "generally acceptable to the people of the community".

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 80-66-1-b of the code is amended to read:

80-66. Variance Permit.

1. TEMPORARY VARIANCE PERMITS.

b. Special Community Events. A temporary variance permit may be issued for special events, such as circuses, 4th of July celebrations and similar community events, which are limited in duration [[and

are generally acceptable to the people of the community;]] >>,<< provided that precautions are taken to maintain the noises produced at the lowest practical level.

Part 2. Section 80-73-3-a-2 of the code is amended to read:

80-73. Excessive Vibration Prohibited.

- 3. VARIANCE PERMIT MAY BE GRANTED.
- a. Temporary Variance Permits.
- a-2. Special Community Events. A temporary variance permit may be issued for special events, such as 4th of July celebrations, which are limited in duration [[and are generally acceptable to the people of the community;]] >> _<<pre>provided that precautions are taken to restrict the vibrations produced to the lowest practical level.
