Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$254,000 for a total estimated cost of these projects being \$4,405,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$254,000 with the total cost estimated to be \$4,405,000.

Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described improvements according to City specifications:

3rd Aldermanic District

E. Belleview Pl. - N. Oakland Ave. to N. Maryland Ave. (SM495180065) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$320,000. This project is anticipated to be completed during the 2019 construction season.

N. Cambridge Ave. - E. Linnwood Ave. to E. Kenwood Blvd. (SM495180075) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for

this project including the requested amount is \$250,000. This project is anticipated to be completed during the 2019 construction season.

N. Cramer St. - E. Bradford Ave. to E. Park Pl. (SM495180064) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$172,000. This project is anticipated to be completed during the 2019 construction season.

4th Aldermanic District

W. Clybourn Ave. - N. 6th St. to N. James Lovell St. (SM495180072) Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$48,000. This project is anticipated to be completed during the 2019 construction season.

E. Juneau Ave. - N. Astor St. to N. Prospect Ave. (SM495180066) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$170,000. This project is anticipated to be completed during the 2019 construction season.

N. Waverly Pl. - 300' north of E. State St. to E. Juneau Ave. (SM495180073) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$65,000. This project is anticipated to be completed during the 2019 construction season.

6th Aldermanic District

N. Nash St. - 160' east of N. 17th St. to N. 18th St. (SM494180031) Relaying storm sewer and Installing new storm sewer. (Infiltration/Inflow Reduction Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$141,000. This project is anticipated to be completed during the 2019 construction season.

N. 4th St. - W. Vine St. to W. Reservoir Ave. (SM495180076) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$130,000. This project is anticipated to be completed during the 2019 construction season.

N. 10th St. - W. Chambers St. to W. Burleigh St. (SM495180077) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$179,000. This project is anticipated to be completed during the 2019 construction season.

N. 11th St. - W. Atkinson Ave. to 160' +/- south of W. Albert St. (SM495180074) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$112,000. This project is anticipated to be completed during the 2019 construction season.

7th Aldermanic District

N. 44th St. - W. Concordia Ave. to W. Townsend St. (SM494180029) Relaying sanitary sewer. (Infiltration/Inflow Reduction Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$108,000. This project is anticipated to be completed during the 2019 construction season.

8th and 11th Aldermanic District

Area bounded by S. 43rd St. to S. 52nd Pl. and W. Lincoln Ave. to W. Oklahoma Ave. (SM494180030) Lining sanitary sewer. (Infiltration/Inflow Reduction Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$1,009,000. This project is anticipated to be completed during the 2019 construction season.

10th Aldermanic District

W. Dixon St. - 140' +/- east of S. 60th St. to S. 60th St. (SM494180033) Relaying sanitary sewer. (Infiltration/Inflow Reduction Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$46,000. This project is anticipated to be completed during the 2019 construction season.

N. 60th St. - 115' +/- north of W. Dixon St. (SM494180032) Relaying sanitary sewer. (Infiltration/Inflow Reduction Fund - \$12,000). The total estimated cost for this project including the requested amount is \$172,000. This project is anticipated to be completed during the 2019 construction season.

12th Aldermanic District

W. Cleveland Ave. - Kinnickinnic River to S. 20th St. (SM495180078) Relaying storm sewer. ((Non-assessable Sewer Maintenance Relay Fund -- \$ 15,000). The total estimated cost for this project including the requested amount is \$300,000. This project is anticipated to be completed during the 2019 construction season.

W. National Ave. - 280' +/- east of S. 9th St. to S. 10th St. (SM495180071) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$154,000. This project is anticipated to be completed during the 2019 construction season.

S. 9th St. - W. National Ave. to 100' +/- south of W. Walker St. (SM495180070) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$219,000. This project is anticipated to be completed during the 2019 construction season.

14th Aldermanic District

S. Clement Ave. - E. Manitoba St. to E. Oklahoma Ave. (SM495180067) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$306,000. This project is anticipated to be completed during the 2019 construction season.

15th Aldermanic District

W. Clarke St. - N. 38th St. to N. 39th St. (SM495180068) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$86,000. This project is anticipated to be completed during the 2019 construction season.

N. 38th St. - W. Wright St. to W. Center St. (SM495180069) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$418,000. This project is anticipated to be completed during the 2019 construction season.
