THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$2,276,000 for a total estimated cost of these projects being \$23,486,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$2,276,000 with the total cost estimated to be \$23,486,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

N. Bremen St. - E. Hadley St. to E. Locust St. (SM495140018): Installing new storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$210,000. This project is anticipated to be completed during the 2014 construction season.

#### 4th Aldermanic District

W. McKinley Ave. - N. 24th St. to N. 24th Pl. (SM495140027): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$82,000. This project is anticipated to be completed during the 2014 construction season.

N. Van Buren St. - 100 feet m/l south of E. Juneau Ave. to E. Knapp St. (SM495140021): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$165,000. This project is anticipated to be completed during the 2014 construction season.

## 4th and 12th Aldermanic Districts

Water St. Bridge over the Milwaukee River (400N) (Bascule, movable) (BR100140106): Preliminary engineering for bridge painting and miscellaneous repairs. (City Share Non-assessable Structure Fund -- \$150,000). The total estimated cost for this project including the requested amount is \$1,550,000. This engineering is anticipated to be completed during 2014 and the construction in 2015.

## 5th Aldermanic District

N. 86th St. - W. Burleigh St. to W. Chambers St. (SM494140201): Foundation drain disconnection. (Infiltration/Inflow Reduction Fund -- \$25,000). The total estimated cost for this project including the requested amount is \$600,000. This project is anticipated to be completed during the 2014 construction season.

## 6th Aldermanic District

N. 3rd St. - W. Concordia Ave. to W. Keefe Ave. (SM495140013): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$61,000. This project is anticipated to be completed during the 2014 construction season.

N. 39th St. - W. Fond du Lac Ave./W. Concordia Ave. to W. Townsend St. (SM495140011): Storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$46,000. This project is anticipated to be completed during the 2014 construction season.

#### 7th Aldermanic District

W. Nash St. - 130 feet m/l east of N. 52nd St. to 130 feet m/l west of N. 53rd St. (SM495140014): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$93,000. This project is anticipated

to be completed during the 2014 construction season.

- N. 52nd St. W. Nash St. to W. Vienna Ave. (SM495140010): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$148,000. This project is anticipated to be completed during the 2014 construction season.
- N. 53rd St. W. Keefe Ave. to W. Vienna Ave. (SM495140009): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$263,000. This project is anticipated to be completed during the 2014 construction season.
- N. 55th St. W. Vienna Ave. to 170 feet m/l north of W. Vienna Ave. (SM495140008): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$70,000. This project is anticipated to be completed during the 2014 construction season.

#### 8th Aldermanic District

- W. Burnham St. S. 35th St. to 350 feet m/l east of S. 35th St. (SM495140023): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$216,000. This project is anticipated to be completed during the 2014 construction season.
- W. Lincoln Ave. S. 35th St. to S. 37th St. (SM495140026): Relaying sanitary and storm sewers. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$282,000. This project is anticipated to be completed during the 2014 construction season.
- W. Scott St. S. 36th St. to S. 38th St. (SM495140022): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$271,000. This project is anticipated to be completed during the 2014 construction season.
- S. 35th St. 300 feet m/l south of W. Burnham St. to 300 feet m/l north of W. Burnham St. (SM495140024): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$166,000. This project is anticipated to be completed during the 2014 construction season.
- S. 37th St. W. Lincoln Ave. to W. Grant St. (SM495140025): Storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$48,000. This project is anticipated to be completed during the 2014 construction season.

#### 11th Aldermanic District

S. 43rd St. - W. Dakota St. to W. Cleveland Ave. (SM495140019): Storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$161,000. This project is anticipated to be completed

during the 2014 construction season.

S. 81st St. - W. Holt Ave. to W. Morgan Ave. (SM495140020): Sanitary Sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$54,000. This project is anticipated to be completed during the 2014 construction season.

12th and 14th Aldermanic Districts

S. 1st St. Bridge over the Kinnickinnic River (2000S) (Bascule, movable) (BR100140107): Preliminary engineering for movable bridge rehabilitation including structural, mechanical, and electrical. (City Share Non-assessable Structure Fund -- \$1,500,000). The total estimated cost for this project including the requested amount is \$15,500,000. The engineering is anticipated to be completed in 2015 and the construction in 2016.

## 14th Aldermanic District

- S. Griffin Ave. E. Ohio Ave. to E. Euclid Ave. (SM495140015): Relaying sanitary and storm sewers. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$511,000. This project is anticipated to be completed during the 2014 construction season.
- E. Ohio Ave. S. Whitnall Ave. to S. Griffin Ave. (SM495140028): Relaying sanitary and storm sewers. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$187,000. This project is anticipated to be completed during the 2014 construction season.

#### 15th Aldermanic District

- W. Garfield Ave. N. 32nd St. to N. 34th St. (SM495140016): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$273,000. This project is anticipated to be completed during the 2014 construction season.
- W. Walnut St. N. 17th St. to N. 19th St. (SM495140017): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$122,000. This project is anticipated to be completed during the 2014 construction season.
- N. 32nd St. W. Lisbon Ave. to 115 feet m/l south of W. Garfield Ave. (SM495140012): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$157,000. This project is anticipated to be completed during the 2014 construction season.

Tree planting for paving projects (ST211140169): (Nonassessable Reconstruction Paving Fund -- \$200,000). The total estimated cost for this project is \$200,000. This project is anticipated to be completed during the 2014 construction season.

2014 Sewer work prior to paving (SM495140500): Sewer work prior to paving. (Nonassessable Sewer Maintenance Relay Fund -- \$100,000). The total estimated cost for this project including the requested amount is \$1,500,000. This project is anticipated to be completed during the 2014 construction season.

## Various Aldermanic Districts

High impact streets resurface by contract, #5 (ST216140105): Asphalt pavement overlay. (Nonassessable High Impact Streets -- \$10,000). The total estimated cost for this project including the requested amount is \$550,000. This project is anticipated to be completed during the 2014 construction season.
