THE CHAIR

A substitute ordinance relating to traffic controls.  
This ordinance establishes the above-mentioned traffic requirements in various parts of the City.  
The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-13-8 of the Code relating to School Speed 20 MPH is amended by striking the following:

“On West Howard Avenue from South 79<sup>th</sup> Street to South 81<sup>st</sup> Street”

Part 2. Section 101-13-8 of the Code relating to School Speed 20 MPH is amended by adding the following:

On West Howard Avenue from a point 270 feet west of South 76<sup>th</sup> Street to a point 350 feet west of South 80<sup>th</sup> Street

Part 3. Section 101-16-1 of the code relating to stop signs is amended by adding the following:

On West Montana Street and South 11th Street in all directions.
