Substitute resolution relative to application for a Wisconsin Department of Transportation State Enhancements - SFY 2001, 2002 and 2003 Grant for the Capitol Drive, Atkinson Avenue and Teutonia Avenue area. - Analysis -

This substitute resolution authorizes the City of Milwaukee to apply for State Enhancements - SFY 2001, 2002 and 2003 Grant from the Wisconsin Department of Transportation in the amount of \$700,000 with a State/City Match of \$175,000 for a total project cost of \$875,000. The purpose of the project is to install pedestrian level harp lights, high level lanterns, trees, and grass in various locations in the subject area. Whereas, The City of Milwaukee ("City") appears to be eligible for grant funds from the Wisconsin Department of Transportation; and

Whereas, The operation of this grant project from January 1, 2001 to December 31, 2002 would cost \$875,000 of which \$175,000 (20 percent) would be provided by a State/City Match and \$700,000 (80 percent) would be provided by the Grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that application to the Wisconsin Department of Transportation for a State Enhancements - SFY 2001, 2002 and 2003 Grant for the Capitol Drive, Atkinson Avenue and Teutonia Avenue area is authorized.
