RESOLVED, by the Board of Directors of Travaux Inc. that they hereby authorize and approve accepting the bid of and entering into a contract with Hurt Electric Inc. for Electrical for Multi-Family Apartment Building 2.2 at Westlawn Gardens Phase 2; and, be it
