This resolution cancels a \$982.10 City of Milwaukee invoice for Department of Public Works services rendered to the Milwaukee Earth Day 2000 Coalition in conjunction with the Earth Day 2000 celebration in MacArthur Square. Milwaukee Earth Day 2000 Coalition was a coalition of non-profit organizations that disbanded after the Earth Day 2000 celebration.

Whereas, A coalition of non-profit organizations, Milwaukee Earth Day 2000 Coalition, held an Earth Day celebration in MacArthur Square on April 29, 2000; and

Whereas, The Department of Public Works provided the following services to the

Milwaukee Earth Day 2000 Coalition in conjunction with the Earth Day celebration: meter hooding, installation of "NO PARKING" signs, provision of electrical service to MacArthur Square; and

Whereas, The Department of Public Works billed the Milwaukee Earth Day 2000 Coalition \$982.10 for the City services rendered (Invoice No. 74000); and

Whereas, Subsequent to the Earth Day celebration, Milwaukee Earth Day 2000 Coalition disbanded; and

Whereas, The Milwaukee Common Council finds that it would be impractical, if not impossible, to collect the money owed by the now-defunct Milwaukee Earth Day 2000 Coalition; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, That City of Milwaukee Invoice No. 740000, being a bill for Department of Public Works services rendered in conjunction with the Earth Day 2000 celebration, is cancelled.
