This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$2,035,000. The total estimated cost of these projects is \$2,400,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

3rd Aldermanic District

E. Linnwood Ave. - N. Downer Ave. to N. Lake Dr. (WT410200642) File Number 181588. Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$500,000). The total estimated cost of this project including the requested

amount is \$525,000. This project is anticipated to be completed during the 2021 construction season.

5th Aldermanic District

W. Concordia Ave. - N. 82nd St. to N. 87th St. (WT410200619) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$510,000). The total estimated cost of this project including the requested amount is \$540,000. This project is anticipated to be completed during the 2021 construction season.

N. Colonial Dr. - W. Auer Ave. to W. Concordia Ave. (WT410200623) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$300,000).

The total estimated cost of this project including the requested amount is \$315,000. This project is anticipated to be completed during the 2021 construction season.

N. 96th St. - N. Colonial Dr. to 240' north of W. Auer Ave. (WT410200622) File Number 181588: (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 - - \$250,000). The total estimated cost of this project including the requested amount is \$270,000. This project is anticipated to be completed during the 2021 construction season.

N. 83rd St. - W. Burleigh St. to W. Concordia Ave. (WT410200621) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$400,000). The total estimated cost of this project including the requested amount is \$425,000. This project is anticipated to be completed during the 2021 construction season.

Handicap Ramp work to meet ADA requirements for 2016 High Impact Projects (ST216200108): File Number 200229: (Nonassessable High Impact Streets -- \$75,000 additional funds). The total estimated cost for this project including the requested amount is \$325,000. This project is anticipated to be completed during the 2020 construction season.
