 THE CHAIR
 A substitute ordinance relating to traffic controls.
 This ordinance establishes the above-mentioned traffic requirements in various parts of the City.
 The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-12-2 of the Code relating to U-Turns Prohibited is amended by adding the following:

On West Capitol Drive at North 7th Street for east and west bound traffic

Part 2. Section 101-16-1 of the Code relating to Stop signs is amended by striking the following:

“On West Arthur Avenue at South 30th Street”

Part 3. Section 101-16-1 of the Code relating to Stop signs is amended by adding the following:

On North 58th Street at West Philip Place

On North 102nd Street at West Beechwood Avenue/West Leon Terrace

On West Arthur Avenue at South 30th Street in all directions

On West Euclid Avenue and South 9th Place in all directions

On West Mineral Street at South 5th Street in all directions

On West Washington Street and South 5th Street in all directions

Part 4. Section 101-16-2 of the Code relating to Through Highways is amended by striking the following:

“On South 9th Place from the south line of West Lincoln Avenue to the north line of West Morgan Avenue”

Part 4. Section 101-16-2 of the Code relating to Through Highways is amended by adding the following:

On South 9th Place from West Lincoln Avenue to West Oklahoma Avenue
